Staff to keep all dance areas clear of all equipment. Making sure the freestanding ballet barre is securely fastened and chairs used for barre stacked correctly. Making sure that tables are moved in Studio 2 as they limit space.</p> <p>**new lighting has been installed in the studio 1, these are very low and can be reached as they are hanging down, concerns that taller students / teachers when jumping may hit their head on them**</p> <p>These were inspected and discussed with Stanway and dance school staff. Drama dept will not move them so dance teachers verbally remind students each lesson to be careful.</p> <p>STUDIO 2 Carpet keeps lifting, tape has been applied for the time. Long term requirement is for a new floor. New floor is planned for this term.</p> |
